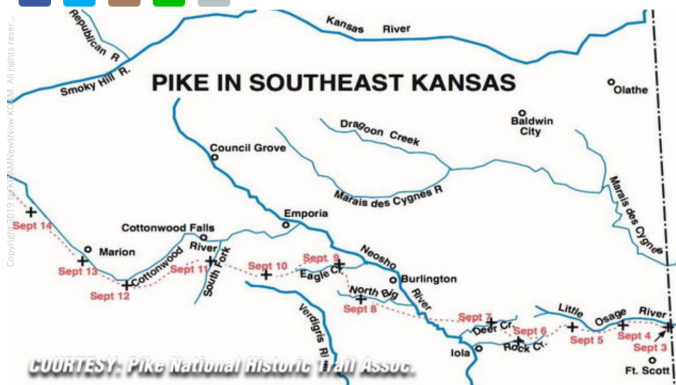

HISTORIC TRAIL IN SEK GETTING NATIONAL ATTENTION

Pike Trail being studied as National Scenic Trail By: Zachary Dodge, KOAMTV Mar 21, 2019



BOURBON COUNTY, Kan. - A local trail with ties to the shaping of America is getting national attention.

That trail -- also happens to go through parts of southeast Kansas.

On March 12th, President Trump signed the National Resource Management Act.. which includes a requirement that the National Park Service study the Pike National Historic Trail for designation as a national scenic trail.

Something that will include parts of southeast Kansas.

Randy Rasa, Thrive Allen County, ABC Trails: "Pike's expedition was probably right up there with Lewis and Clark." According to the Pike National Historic Trail Association,

Lieutenant Zebulon Pike set out from Fort Bellefontaine, Missouri to explore the newly purchased Louisiana territory in 1806 -- something that would take him along the Little Osage River in Bourbon county, and through Allen County.

Jody Heoner, Bourbon County Economic Development Director: "Any time that we're able to get any federal or national recognition, it would be.. it's just wonderful for our community because any time we can promote or raise awareness of the quality of life that we have here in rural communities, [it] helps."

Designating a bike and auto route that would follow along Pike's trail is also part of the ABC Regional Trail plan, that connects Allen, Bourbon, and Crawford counties."

Rasa: "I visualize probably a signed bike route and there would probably be a parallel auto tour route as well. And perhaps we would add some interpretive historical signage, to say, at this point, Zebulon Pike saw this."

THE PIKE FAMILY - THE LOWER PORTION OF THE PIKE GENEALOGY TREE (CONTINUED)

Zebulon Montgomery Pike Sr. (1900-1985) was the first person named for our explorer in modern times. Monty Sr and Emily (nee Dennis) Pike begot four sons 1. Monty Jr. (1922- Living: the closest living relative to our explorer and Vice President Emeritus in our Association), 2. Edward L (1924-2015 whose son Brian is one of the Association's VPs), 3. Dennis H (1926-2015) and 4. Clifford L (1928-1990)(see top of chart in our March issue). Each of these sons distinguished themselves in the US Military as their 4x Grand Uncle- Monty Pike. This article focuses on Dennis H Pike (1926-2015) and Clifford L Pike (1928-1990).

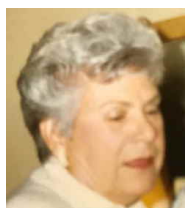

When Clifford Llewellyn Pike was born on Sep. 29, 1928, in Golden, Colorado, his father, Zebulon Montgomery Sr., was 28 and his mother, Marion “Emily”, was 31. At 21 he married Donna Rae Evenson on February 22, 1950. Clifford served in the military beginning on September 11, 1950, in North Korea when he was 21 years old. SGT US ARMY KOREA. They had two children during their marriage- Clifford Scott Pike (1950–L) and Steven Randolph Pike (1952–L). He died on December 13, 1990, in Kittredge, Colorado, at the age of 62, and was buried in Denver, Colorado.

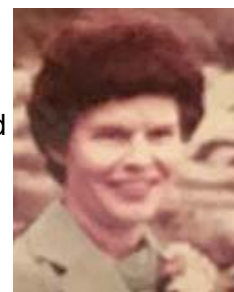

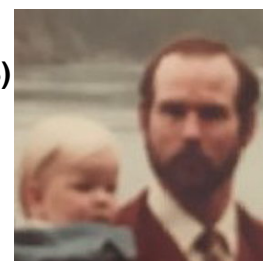
