I. Sites There are sites and areas that could be visited by the public in Colorado including:

**A** I enjoy driving up the Pikes Peak highway, riding the Pikes Peak Cog Railway or hiking on Barr Trail to the top of Pikes Peak, being reminded that Zebulon Pike attempted to climb this fourteener, that <u>America the Beautiful</u> was inspired here and enjoying the magnificent scenery

**B** Hiking and backpacking in Colorado is unbelievable. Near the Pike route are 19+ fourteeners (14,000 feet) with marked hiking trails: Mount Elbert, Mount Massive, Mount Harvard, Blanca Peak, Crestone Peak, Mount Lincoln, Mount Antero, Mount Shavano, Mount Princeton, Mount Belford, Mount Yale, Mount Bross, Tabeguache Peak, Mount Oxford, Mount Democrat, Pikes Peak, Mount Columbia.

**C** Along the Pike route, I enjoy bike and hiking trails along the Arkansas and Rio Grande rivers, fishing, river rafting, and scenic driving. Hiking up High Dune at the Sand Dunes was special. I was walking to where Pike was.

**D** Colorado historic sites are varied and diverse along the Pike route, like ... (see chart below). They are numerous and enlightening. South Park City Museum [Fairplay, CO], Silver Cliff Museum

**E** I have run into people from all over the world at such places as Bents Fort, South Park National Heritage Area, Browns Canyon National Monument, and Great Sand Dunes NP .

It was interesting that a Pike quote is etched on the Visitor Center window at the Sand Dunes.

- **B** Pike's route is historically significant especially along the Missouri, Osage, Cottonwood, Arkansas, South Platte and Rio Grande rivers. It had a far reaching effect on broad patterns of American culture, trade and commerce, exploration, migration and settlement
- **C** Pike's southwest exploration Missouri, Kansas, Nebraska, Colorado, New Mexico, and Texas became states
- **D** I can imagine the Utes in Colorado observing Pike and his men travel on their hunting grounds. Native Americans were impacted positively with American compassion. They learned to respect American sovereignty
